Conditions of Permit:

- Permit Holder has obtained liability insurance which shall be kept in force during the term of the permit which names Lyon Township as an additional insured in the amount of \$1,000,000.00.
- Permit Holder acknowledges responsibility for safe and proper installation of a public dock, maintenance of a dock free from defects which may cause injury to person or property, and removal of the dock prior to expiration date or upon Order as provided herein. Permit Holder accepts responsibility for any injuries or damages that may occur as a result of the installation and use of the public dock.
- The Dock is to be open for public use consistent with the decisions of the courts of the State of Michigan and all applicable laws, including MCL 324.30111b, as amended. This includes, but is not limited to, ensuring that no activity on, near, or relating to the dock obstructs ingress or egress from any inland lake or stream, and ensuring that no vessels are be moored or docked between the hours of midnight and sunrise.
- Lyon Township reserves the right to ensure the location of the dock does not obstruct ingress or egress from the lake. If a determination is made that a permitted dock obstructs ingress or egress from the lake, Permit Holder will be required to relocate the dock or this permit will be revoked. Permit Holder agrees that, as a condition of this permit, he or she shall hold Lyon Township and its officials harmless from any liability relating to the dock and to indemnify the Township for any expenses, damages, costs, and fees (including court costs and attorneys' fees) arising out of a legal action related to the dock authorized by this permit.

This permit may be revoked at any time, upon order of the Lyon Township Board. The dock shall be removed by Permit Holder within five (5) days of notice of order of revocation/removal. Failure to remove a public dock prior to expiration date, or pursuant to order of revocation/removal, shall result in removal of the dock by public officials and forfeiture of dock in addition to any other penalties authorized above.
